Mr. Boehm opened the meeting at 5:05 p.m. and stated that the meeting had been duly advertised and the public properly notified through notification to The Express-Times, NJ Herald and the White Township Municipal Clerk in accordance with the Open Public Meetings Act.

Mrs. Huff noted that only two bids were received for the project. Upon review of the low bidder documents it was discovered that appendix X – Sworn Contractor Certification was missing for the subcontractors listed on the project. Mrs. Huff noted that it is the opinion of both the Architect and the Attorney that these documents are likely nonmaterial and waivable and we can proceed with the award of the bid. Mrs. Huff noted that the project will start the last week of June and that substantial completion is slated for August 9^{th} .

1. <u>Approve a Resolution Awarding a Contract for the Main Office Security Vestibule to Coopersmith</u> Bros. Inc.

WHEREAS, pursuant to N.J.S.A. 18A:18A-1, et seq. the White Township Board of Education advertised and solicited bids for the main office security vestibule project at White Township Consolidated School; and

WHEREAS, the Board received bids from the following:

Coopersmith Bros. Inc. Base Bid - \$174,000

Precision Building & Construction Base Bid - \$262,460

WHEREAS, the lowest base bid received was from Coopersmith Bros. Inc. in the amount of \$174,000, and

WHEREAS, the Project Architect has reviewed the bids and recommends awarding the project to Coopersmith Bros., Inc. and the Board has determined that Coopersmith Bros., Inc. is the lowest responsible and responsive bidder.

NOW, THEREFORE BE IT RESOLVED, by the White Township Board of Education that the Board hereby awards a contract for a main office security vestibule project at White Township Consolidated School to Coopersmith Bros., Inc. in the amount of \$174,000 for the base bid only, no alternates.
